ACH Authorizations

1. Bank Transfer Authorization

When your checking account is used as your funding source, you are requesting that we initiate on your behalf an electronic transfer from your bank account. For these transactions, York Funding and its affiliates, located at 37-18 Northern Boulevard, Suite 417, L.I.C., N.Y., 11101 will make electronic transfers (via the Automated Clearing House ("ACH") of NACHA - The Electronic Payment Association ("NACHA")) from your bank account in the amount you authorize.

You agree that such requests constitute your authorization to Company to make the ACH transfer, and once you have provided your authorization for the transfer, you will not be able to cancel the electronic transfer and Company may resubmit any ACH debit you authorized that is returned for insufficient or uncollected funds, except as otherwise provided by NACHA's ACH rules, or applicable law.

2. Consent for Electronic Signatures, Records and Disclosures (“E-Sign Consent”)

Please be aware that your consent to the electronic delivery of disclosures will be required before you will be able to begin using your Privacy Account. If you are unable or unwilling to provide such consent, please do not enroll for a Privacy Account. Once you have activated your account, you may withdraw your consent for E-SIGN and request paper communications and/or disclosures as noted below under section 3.

Note: This Electronic Communication Disclosure (“E-Sign Consent”) applies to any and all communications and/or disclosures that we are legally required to provide to you in writing in connection with your Privacy Account and any related products and services (“Communications”). This E-Sign Consent supplements and is to be construed in accordance with the terms contained in the Terms of Service Agreement (“Agreement”) you received from York Funding LLC and its affiliates. The words "we," "us," and "our" refer to York Funding and its affiliates, 37-18 Northern Boulevard, Suite 417, L.I.C., N.Y., 11101. The words "you" and "your" or “Account holder” mean the Privacy Account holder. As used in this E-Sign Consent, "Privacy Account" means the account you have with us.

1. Scope of Communications to Be Provided in Electronic Form

When you use a product or service to which this E-Sign Consent applies, you agree that we may provide you with any Communications in electronic format, and that we may discontinue sending paper Communications to you, unless and until you withdraw your consent as described below. Your consent to receive electronic communications and transactions includes, but is not limited to:

3. How to Withdraw Consent

If you withdraw your consent, your Privacy Account and all associated cards will be closed in accordance with our Terms of Service Agreement and we will send subsequent required communications and disclosures to you in writing to the most current address we have on file.

We will not impose any fee to process the withdrawal of your consent to receive electronic Communications. Any withdrawal of your consent to receive electronic Communications will be effective only after we have a reasonable period of time to process your withdrawal. In the meantime, you will continue to receive Communications in electronic form. If you withdraw your consent, the legal validity and enforceability of prior Communications delivered in electronic form will not be affected.

4. How to Update Your Records

It is your responsibility to provide us with a true, accurate and complete e-mail address, your contact information, and other information related to this E-Sign Consent and your Privacy Account, and to maintain and update promptly any changes in this information. 5. Hardware and Software Requirements

To read some documents, you may need PDF file reader like Adobe® Acrobat Reader Xpdf® or Foxit®. If these requirements change while you have an active Privacy Account, and the change creates a material risk that you may not be able to receive Communications electronically, we will notify you of these changes. You will need a printer or a long-term storage device, such as your computer's disk drive, to retain a copy of the E-Sign Consent for future reference. 8. Federal Law

You acknowledge and agree that your consent to electronic Communications is being provided in connection with a transaction affecting interstate commerce that is subject to the federal Electronic Signatures in Global and National Commerce Act, and that you and we both intend that the Act apply to the fullest extent possible to validate our ability to conduct business with you by electronic means.

9. Termination/Changes

We reserve the right, in our sole discretion, to discontinue the provision of your electronic Communications, or to terminate or change the terms and conditions on which we provide electronic Communications. We will provide you with notice of any such termination or change as required by law.
